# Introduction

The Office of the Governor offers proclamations, greetings and recognitions, and milestone achievements to constituents throughout our state. ### Proclamations

Proclamations are ceremonial documents issued by the governor to recognize and bring awareness to days, weeks, and months observing particular issues and causes. Proclamations are not typically issued to honor specific organizations or individuals, but rather to recognize issues of statewide importance.

# **Greetings/Recognitions**

The governor issues greetings/recognitions in the form of letters and certificates to recognize the extraordinary contributions of Wisconsinites and Wisconsin-based organizations across our state. Examples of previously issued greetings/recognitions include:

- Noteworthy individual or organizational achievements
- Organizational anniversaries
- Event greetings

# **Milestone Achievements**

Every day, Wisconsinites achieve important personal and career accomplishments, and the Office of the Governor wants to help you celebrate. To commemorate these achievements, the governor processes requests made by Wisconsin residents to recognize the following milestones:

- Wedding Anniversaries
- Birthdays
- State Employee Retirement
- Military Retirement
- Police Retirement
- Teacher Retirement

Stat. §§ 19.31-19.39), and that it is generally our policy to release communications submitted through this website when requested via a public records request. Except as otherwise provided by law, any requester has a right to inspect any public record. Therefore, any information contained within your submission may be open to public inspection upon request.

# **Request a Proclamation**

All proclamations are reviewed on a case-by-case basis and issued at the discretion of the Office of the Governor. The Office of the Governor reserves the right to decline or modify requests as received. Please review the guidelines below before submitting a request.

# Requirements

- All proclamation requests must be made by a Wisconsin resident, including those coming from national and international organizations.
- Requests must be made no fewer than 45 days in advance of the date you need the proclamation.
- Each request for a proclamation must be accompanied by draft language composed of unique text in the ceremonial proclamation format, including the "<u>WHEREAS</u>" sentence structure (see example), and verified sources for any empirical information. This includes highlights and statistics about the history of the occasion being recognized, its significance to our state/country, and comments about its ongoing relevance.
- Proclamations must affect a broad group of people and should not take sides in matters of political controversy, nor should they address personal or individual convictions.
- No proclamation may be used as part of an advertisement or commercial promotion without the express permission of the Office of the Governor. Any use of the proclamation in a news release or other type of publication must be approved by the Office of the Governor prior to publication.
- No more than 2 requests by the same organization will be honored within the same calendar year.
- Proclamations will be delivered no more than two weeks in advance of the proclamation date.
- Proclamations are not automatically renewed from year to year. You must submit a new proclamation request for each year.

### What to Include

- Contact person's first and last name, email address, delivery address, and telephone number.
- A brief summary and/or background of the requesting entity.
- The name and date(s) of the day, week, month, or event to be proclaimed.
- Proposed text for the proclamation, including 4-6 "WHEREAS" clauses.
- An indication of whether the completed proclamation should be mailed (standard U.S. mail) or if you will pick it up.
- A date indicating by when the proclamation is needed.
